# ARTICULATION AGREEMENT BETWEEN STATE UNIVERSITY OF NEW YORK COLLEGES AT SUNY ONEONTA AND MOHAWK VALLEY COMMUNITY COLLEGE

## MOHAWK VALLEY COMMUNITY COLLEGE DIETETICS (A.S.) ARTICULATED TO

#### SUNY ONEONTA - DIETETICS (B.S)

This agreement is intended to facilitate the transition of graduates from an associate degree program at Mohawk Valley Community College (MVCC) to a baccalaureate degree program at SUNY Oneonta (Oneonta). Oneonta and MVCC recognize their responsibility to students from their regions, as well as from the rest of New York State, to insure a smooth transition between the two institutions. Both institutions have made a strong commitment to help transfer students maximize their opportunities

- 1. MVCC students who have graduated or will graduate with an Associate in Science (A.S.) in Dietetics Studies, who apply in a timely manner and meet the admission criteria at the time of application, will be admitted to the Bachelor of Science (B.S.) degree program in Dietetics as matriculated students with junior status at Oneonta.
- 2. Table 1 shows MVCC A.S. in Dietetics degree requirements and Oneonta equivalent courses. Oneonta will accept a maximum of 75 semester hours from MVCC toward fulfilling the B.S. Dietetics degree requirements. Further information on Oneonta's transfer credit policy can be found on its website, Transfer Credit.
- 3. Oneonta will advise MVCC of any changes to the course equivalencies listed in this agreement.
- 4. Students are advised to consult both the MVCC and Oneonta college catalogs regarding any modifications or changes to program requirements.
- 5. This agreement will come into effect on October 1, 2021. Each institution will make a good faith effort to regularly update the other institution regarding any changes to programs and requirements. This is a joint effort on the part of both institutions to help transfer students maximize their transferability.
- 6. This agreement will be reviewed in the fall of 2026 by contact among the articulation coordinators and department chairpersons/directors/coordinators at both institutions. Each institution assumes responsibility for making this a viable and workable agreement for interested students.

7. Each institution may carry out publications and marketing of this agreement. This can include, but is not limited to, printed material, websites, and inclusion of admissions material.

To be assured admittance to the B.S. Dietetics program at Oneonta under the terms of this agreement, all students must:

- be in good academic and student standing with MVCC,
- have a minimum MVCC cumulative grade point average (GPA) of 2.5,
- have completed and been awarded the A.S. Dietetics degree,
- have followed the prescribed process in applying to Oneonta and furnished a final transcript with the degree posted, and
- have earned a grade of B- or higher in each major and major-related course that is to be transferred. The courses are listed below:

Upon acceptance to Oneonta, students who are transferring into the B.S. in Dietetics with a MVCC associate's degree will be:

- provided a transfer credit evaluation and advisement document outlining coursework to be completed
- awarded junior status
- considered for all Transfer Scholarships available through the Office of Admissions without filing any additional paperwork, and
- advised toward the successful completion of degree requirements by their academic department

Oneonta will extend every opportunity to help full time students who begin their Oneonta courses in the fall semester to complete the B.S. Dietetics degree in two additional years of full-time study. The course selection included in this articulation may be subject to change as new requirements are established for B.S. Dietetics majors

#### INFORMATION ABOUT RETENTION IN THE MAJOR:

Students are required to:

- 1) Earn a minimum cumulative GPA of 3.0 or higher by third semester (sophomore year) or second semester for transfer students. If the 3.00 is not earned, students are permitted one more semester to earn a 3.00. Failure to earn a 3.00 cum GPA will result in removal from the major.
- 2) Earn a minimum grade of "B-" in all, but two, major and major-related work courses. With program director approval, students may have up to 2 grades in the C- to C+ range when the cumulative GPA is 3.0 or above.

In addition, a student may repeat no more than three required courses in the major.

Students who have been dismissed from the major may appeal to the Dietetics Committee for re-entry to the major based upon extenuating circumstances or a rectified GPA. Re-entry to the major is not guaranteed." The Dietetics Program is a Didactic Program which prepares students to meet the educational requirements of the Accreditation Council for Education in Nutrition and Dietetics Education (ACEND). In addition, an

of the Accreditation Council for Education in Nutrition and Dietetics Education (ACEND). In addition, an ACEND accredited supervised practice experience and passing a registration examination are required to become a registered dietitian. Supervised practice experiences are nationally competitive and completing an undergraduate degree does not guarantee that a student will receive a placement. After graduation, supervised practice programs require written verification of the student's completion of the academic requirements. Upon student request, Oneonta issues verification statements to all students who graduate with a B.S. in Dietetics. Students should obtain current policies from the program director. Students will be charged a fee if verification is requested two months or more beyond graduation. Effective January 1, 2024, a minimum of a master's degree will be required to take the registration examination by the Commission on Dietetics Registration.
