II. Academic Integrity Policy Workgroup Report: R. Wittenberg, C. Ehrlich, S. McCall

- i. Academic Integrity Policy updated review document of Proposed versus Current policy. Some updates include:
 - 1. Updating policy to include more current technologies (e.g., smartphones)
 - 2. Updating policy to include AI
 - a. References to persons made more general to include AI
 - 3. Include why Academic Policy is important
 - 4. If you instructor has a different policy, that trumps the Academic Integrity policy
 - 5. Policy for Duplicate Submission of the Same Work
 - 6. Parsed information to be easier to navigate
 - 7. Included a Syllabus Statement on Academic Integrity Suggestion
- ii. Questions/Comments: Should approach sections on AI with consideration on how AI will evolve over the coming years. *Response: Instructors will have to be explicit on whether or not AI use is allowed.*

- iii. Questions/Comments: Should we name websites directly (even as examples) as the website may change their business model?
- iv. Questions/Comments: If we don't name sites specifically, then students may not realize that these websites aren't OK to use. We can use this as a teaching document for students. Helps to create clarity.
- v. Questions/Comments: How to handle egregious cases of violations? *Response:* Will be future work. This workgroup just handles policies, not procedures. Deans are aware of the desire to create continuity among the schools and tracking mechanisms.
- vi. Questions/Comments: Were student voices included in this decision? *Response:* No. There is a student chair on the committee, but they are having a problem filling. Will discuss whether to bring it to Student Congress. Timing is an issue at this point in order to have it in place for the fall.
- vii. R. Wittenberg motioned to have the Faculty Caucus endorse the Academic Integrity Policy. E. Bush seconded
 - **a.** Passed TEAMS Poll (13 Approved Poll, 0 No, 0 abstained poll, 1 approved verbal = 14 total responses)
