## REVIEW AND APPROVAL OF THE MINUTES OF THE MAY 7, 2019 MEETING

## **CHAIRPERSON'S REPORT**- A. Haines

Senate Advisory: whomever was on Senate Advisory last year will continue to be on Senate this year.

Bylaws Review: Reordered

Committee Charter reviews: All committees will review charters to have a standard look for all. No questions were posed.

## STUDENT GOVERNMENT REPORT

Kupr reported that the first meeting will be held Thursday. Treasurer and Secretary being sought. Treasurer position is an application not elected position. Qualifications to apply for treasurer are 1) student must have a term GPA 2.5 or higher and be enrolled in 9 or more credits. Every Student Committee member is a paid position at minimum wage times 10 hours per week. Kupr stated they are seeking for all to be paid equally. Student Congress would like to appoint a Parliamentary/Director to be sure they are following proper procedures. Currently it is six representatives overseen by Kupr.

## VICE PRESIDENT'S REPORT

T. Squires reported on Rome Campus renovations. Radon issues involving multiple projects with ventilation. New basement under Culinary, tested for Radon-it was acceptable. Usage of

Culinary space, created air pressure which forced Radon to reappear. Learning Commons Library has elevated Radon. The Library and Auditorium are the only buildings closed due to elevated Radon levels. Currently there is one bid for the work to be completed, looking to be completed by the end of Fall semester. Radon should be checked annually—it will be checked biannually everywhere. There are no fears of being in buildings.

Interior signage for the Utica campus still being completed. S&T money requested from County, along with LED signage on Culver and abatement of floors (abatement of floors will be completed over a four year period). The Culver corner signage will be included with the multipurpose stadium project. The County is responsible for creating 9-1-1 road signs for "You Are Here". The IT and JC buildings are currently the only buildings in ADA compliance. The IT bldg. is getting rebuilt to be named Wilcox Hall. IT is to be used currently on syllabi and other notices, there is a target date of October 1, 2019 for rebuild. Renumbering rooms in the Academic Building still in works.

Two additional workgroups were created and seeking Chairs: Design Analysis and Assessment (2 co-chairs) and Universal Teaching & Learning (0 chair). It was suggested that Alen Smajic from Marketing be on the Guided Pathways Council.
