**President's Report** 

April 7, 2020

I want to thank everyone again for the incredible individual and collective efforts to transition into our current remote operations. From what I've gathered, things went about as well as we could have hoped for under the circumstances. I'll be meeting with the Crisis Team to do a "hotwash" review of our two weeks of transition to identify what we did well and what we can learn from where we need to improve for future events.

#### **COVID-19 Response**

As reports and projections continue to indicate that the worst of the pandemic is yet to occur, we are making preparations. While we have just over 20 students staying in the residence halls due to special circumstances, we are working to lock and secure as many buildings on the Utica Campus as possible. The Rome Campus is locked and secure while the Utica Library remains open for students who need access to technology. The SUNY Chancellor has secured 5,000 laptops from Dell and HP for colleges to create laptop loaner programs for students in need. Our first shipment of laptops arrived on Friday. We hope to have laptops in the hands of every student who needs one very soon. Along with Spectrum's free Internet option, we believe all students will have their technology needs met, which will allow us to subsequently close the library as well.

#### **Budget**

Cabinet continues to work with budget managers on developing the budget for the 2020-21 fiscal year. While we continue to do our typical analytical work of reducing the budget where possible without sacrificing too much, this year we implemented our first blanket reduction by asking budget managers to do a 10% across-the-board cut. Everyone stepped up and made a great effort with this. Unfortunately, the State budget that passed on April 1, did not include an increase for community colleges – this means we absorb the full impact of our enrollment decline. When coupled with the impact of the losses in sales tax, bed tax, and casino revenue on the County budget, next year will present significant challenges. While the context is even more difficult than years past, we remain on track to present a balanced budget to the Board at their May Board meeting.

#### **Commencement/Graduation Ceremony**

I recently convened a group of faculty and staff to explore ways to reimagine graduation for this year's class. Given the imposed limits on large gatherings, our May 8<sup>th</sup> ceremony at the Adirondack Bank Center is not possible. Unlike a few other colleges, I have resisted an immediate announcement of

simply cancelling graduation. Commencement is certainly special to every graduate, but I believe our students deserve every ounce of creativity we can offer them to identify alternative ways to mark this special moment for them — many of whom are the first in their families to graduate. I will share a tentative plan for discussion during the Senate meeting on Tuesday.

MVCC College Senate Faculty Caucus Report Tuesday April 7, 2020

Due to the closure of the college the March Caucus meeting was postponed. The plan is to have a virtual meeting on Tuesday April 21st starting at 2:30. One of the items on the Agenda will be a presentation by members of the Guided Pathways Universal Teaching and Learning workgroup who will present their current recommendations for discussion. This will be the last meeting of Senate Faculty Caucus for the Spring 2020 semester.

### MVCC College Senate FCCC Report Tuesday April 7, 2020

April plenary was cancelled. Still having work group meetings. There was a call with the provost on Thursday 4/2. Some of the major items discussed during that call are listed below.

- Funding: Not expecting to get the funding floor we got last year. It appears that community colleges may be at a disadvantage in funding over the state ops. There is some flexibility with the Budget director to help allocate funds, but not a lot of clarity was given about how that would work. It was also mentioned that community colleges may do better because people will want to stay close to home.
- Recruitment: SUNY is asking colleges to be flexible with students who applied in good faith and
  are unable to schedule ACT or SAT exams due to corona virus. Consider using multiple measures
  for these students this time.
- Pass/ Fail: Guidance on this issue should be coming out before senate meets but the current stance is that SUNY would try to enforce the state ops to take Gen Ed on a pass/fail basis for credit. Courses for a major would probably not be accepted that way. This will require careful advising. No agreements with private colleges.
- Excelsior Scholarships: Current wording from SUNY: The term will not be used when considering program eligibility for impacted recipients.
  - o Recipients not held to annual 30 earned credits requirement
  - Term not completed by the impacted student will be considered an approved break in study
  - Student will not lose program eligibility for not being continuously enrolled full time in an approved program of study. When asked straight up if that also applied to students who electively chose to drop classes, the answer was "probably".

#### • General Information:

- Summer term will probably be online, and Fall may not look like it has in the past.
- Definition of Essential personnel –Those whose work is needed to keep the college running and can only be done in person, or people responding to the Corona Virus.
- Consolidation SUNY is working very hard to keep the campuses all solvent and running. No real explanation of how to do that though.
- Eduroam allows students to use Wi-Fi at any SUNY campus with their current student log in. Trying to make this happen.
- Lap top loan program. 10,000 laptops statewide.
- Three current presidential searches that will continue into the Fall; Suffolk, Monroe, and Fulton Montgomery.
- Meeting next Wednesday with the chancellor and a liaison from the Board of Trustees.
   We can email questions ahead of time.

# MVCC College Senate Guided Pathways Council Report Tuesday April 7, 2020

- We continue to work on intake and onboarding implementation. At this point we have made the decision to transition some of the implementation tasks directly to the supervisors/directors overseeing specific areas.
- After soliciting feedback in open forums and Faculty Caucus, the Assessment of Prior Learning Workgroup has submitted their recommendations to Council and the Vice Presidents for review.
- The Design, Assessment, and Analysis Workgroup and the Universal Teaching and Learning Workgroup were scheduled to host open forums this month. Rather than traditional open forums, they will be doing something with Zoom. This will allow everyone to review their draft recommendations and give feedback.
- We have two new workgroups that are just starting to meet. These groups are the Undecided Workgroup and the Orientation and First Semester Experience Workgroup.
